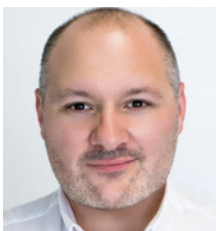

MARY FITZGERALD, FOUNDER AND DIRECTOR OF FITZGERALD'S WOODLANDS HOUSE HOTEL, ADARE

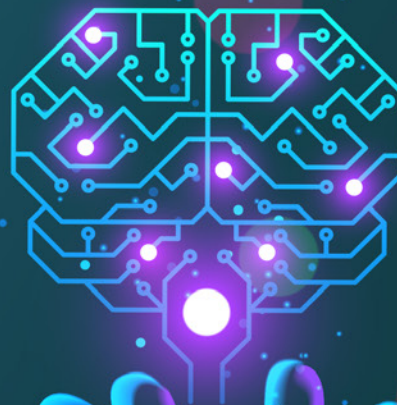
